

Citizen's Complaints Against Peace Officers (CCAPO)

Data Set Overview and History

The Citizen's Complaints Against Peace Officers (CCAPO) data provides annual summary information on the number complaints reported by citizens against law enforcement personnel. Assembly Bill 953 (2015) modified the reporting requirements to also include complaints based upon racial and identity profiling claims. 2016 was the first year of collection under the new reporting requirements. Prior to 2016, the data was only released at the statewide summary level; no agency specific data was published. Two files are provided for use: 1) Agency Level Data for the years 2016 to the present; and 2) Statewide Data for the years 1981 to the present.

Statutory Authority

The CA DOJ has statutory authority to collect CCAPO data pursuant to PC Section 13012(e).

Data Characteristics and Known Limitations

1. Setting up policy and procedures for collecting information regarding complaints against peace officers is statutorily left up to the discretion of the agency (PC section 832.5). Therefore, each agency could implement and outreach differently which could affect the number of complaints (in either direction...more or less) they receive and caution should be taken when comparing across agencies who may have different policies.
2. CCAPO collection is under a California statute. We do not send this data to the FBI.
3. The CCAPO data set contains information submitted by some local and state agencies that do not report any other data to us (i.e. fire departments, district attorneys, housing development agencies etc.). The primary requirement for reporting is that the agency employs peace officers as defined in PC sections 830-830.6. This means we will have complaint data in this file and no corresponding arrest or crime data for some agencies. In 2017, some of these agencies are not represented in the data file as they indicated they did not employ peace officers
4. State agencies report one set of numbers for the entire state (county level information is not available). Similar to the Law Enforcement Personnel data, entities such as CHP, which have a presence in each county, only report one number to us for the agency as a whole.
5. Large agencies that contract for community policing services only report one set of numbers. The data is based on the actions of a department, not the activity within its contract cities. For instance, you will find arrest and crime data for the city of Compton but because Compton is a contract city of the LA Sheriff Department, you will only find complaint data reported under the LASD. Since this is the case for several of our larger counties, one must take caution in comparing these data sets. The data reported for counties with large amounts of contract agencies will appear disproportionate to the number of arrests and crimes reported for that agency. Using the example above, LASD reports 50 LEA Personnel, 20 complaints, 100 arrests and 60 crimes. The numbers appear disproportionate because one would need to take all the arrest and crime data for the contract agencies into account to see a proportionate reference to the personnel and complaints reported.

6. California Department of Corrections and Rehabilitation represents a large number of complaints annually, but does not report any UCR (crime or arrest) data.
